



## **Call for applications to the comparative selection procedure for n. 3 collaboration contracts on the EU funded project BETKOSOL**

### **1. Premise**

A comparative selection procedure, based on qualifications and possible interview, approved by Luiss CE, is organized to assign n. 3 collaboration contracts – according to the National Collective Bargaining Agreement for Collaborators at Private Universities (ACNC) – for supporting research activities related to the project BETKOSOL (G.A. n. 101015421, CUP I89C20000440004), funded by the EU within the framework of the Hercule III (HERC - 2014-2020) program (hereinafter "the project").

### **2. Subject of the contract**

The project aims to investigate the limits and perspectives of an improvement of the current regulatory framework to combat against frauds affecting EU financial interests, in particular in the social, health, and economic sectors, and taking into account how the COVID-19 crisis may affect the status quo.

The purpose of this comparative evaluation selection procedure is to select 3 collaborators for carrying out the following research activities:

- Position n. 1: Comparative analysis of the anti-fraud legal framework of the EU Member States (focus on Germany and Belgium) and comparative empirical research on the EU anti-fraud legal framework. The research activity will focus on fraud against the EU involving funds in support of labor and the social sector, taking into account aspects relating to criminal law.
- Position n. 2: Analysis of the anti-fraud legal framework in force in Italy, including a comparative analysis with respect to the anti-fraud legal framework of the EU Member States. Research will focus on EU fraud involving criminal offenses.
- Position n. 3: Analysis of the anti-fraud legal framework in force in Italy, including empirical research, data collection and processing of case studies. The research activity will be focused on EU fraud involving criminal offenses.

### 3. Location, duration and remuneration

Project research activities to be carried out will belong to Luiss, under the supervision of the Scientific Coordinator of the project, who will verify correct performance of the contract and the consistency between results achieved and objectives set.

- Position no. 1

Duration: from the first day of the month following the awarding of the contract to the 30/06/2022

Estimated number of working days: 138.89

Maximum gross amount depending on the fiscal regime of selected candidate: 10.308,42 euro

Duration: commencing from the first day of the month following the awarding of the contract to the 30/06/2022

Estimated number of working days: 69.45

Maximum gross amount depending on the fiscal regime of selected candidate: 5.154,46 euro

The amount includes contributions to be paid by the researcher.

- Position no. 3

Duration: commencing from the first day of the month following the awarding of the contract to the 30/06/2022

Estimated number of days: 69.45

Maximum gross amount depending on the fiscal regime of selected candidate: 5.154,46 euro

The amount includes contributions to be paid by the researcher.

Any necessary travel expenses incurred by the selected people for the performance of the appointment during the term of contract will be reimbursed if duly authorised in advance in writing by the Scientific Coordinator and upon submission of appropriate supporting original documentation evidencing the expenses, in compliance with the University's internal regulations, national law and the relevant provisions of the Grant Agreement of reference.

The remuneration will be paid in deferred monthly instalments from project funds.

#### 4. Admission requirements

Admission to the comparative selection procedure is allowed providing the following requirements, failing which the candidate will be excluded:

- a) four-year and/or master's degree in law, obtained at an Italian university or similar academic qualification (of at least the same duration) obtained abroad;
- b) **for positions no. 2 and 3 only**, knowledge of criminal law - report any exams taken in the CV;
- c) **for position no. 1 only**, knowledge of labor law and social law - report any exams taken in the CV;
- d) excellent knowledge of written and spoken English - indicate in the CV the level held and any certifications;
- e) **for positions 2 and 3 only**, knowledge of the Italian language, if foreign citizens;
- f) maximum age of 35 years.

In any case, for admission to the comparative evaluation selection procedure it is necessary that the candidates:

- g) hold Italian citizenship (Italians who do not belong to the Republic are treated as Italian citizens) or citizenship of one of the Member States of the European Union, or citizenship of a third country;
- h) enjoy of their civil and political rights;
- i) not have a criminal record and not be the addressee of measures concerning the application of preventive measures, civil decisions and administrative measures entered in the criminal records database;
- j) be aware that they are not undergoing criminal proceedings.

The following requirements will be positively evaluated:

- IT skills (Excell, Word, WordPress, Canva);
- for position no. 1, knowledge of German, French and Dutch (indicate in the CV the level held and any certifications);
- academic qualification of PhD, obtained both in Italy and abroad, consistent with the objectives of the BETKOSOL project;
- a scientific-professional curriculum suitable for conducting research activities;
- documentable research activity in public and private entities, in Italy and/or abroad.

Candidates in possession of an academic qualification obtained outside Italy attach to the application the useful documents in order to allow the evaluation of their qualification, in compliance with the legislation in force in Italy and in the country where the title and international treaties or agreements were issued.

This comparative selection procedure is not open to those who, on the date of the deadline for the submission of applications, are related, by blood or marriage up to the fourth degree inclusive, to a professor affiliated with the department or unit responsible for this notice of competition, the Rector, the General Manager or a member of the Board of Directors of the University, pursuant to articles 18(1)(b) and 18(1)(c) of Law No. 240/2010 as amended.

The prescribed requirements must be fulfilled by the deadline set out herein for the submission of applications. In the absence of fulfilment of the prescribed requirements for admission or in the absence of a declaration of their fulfilment, the candidate will be excluded from the procedure.

Candidates are admitted conditionally. At any time and by means of a decision stating the reasons therefore, the Administration may exclude a candidate from the procedure for failure to fulfil the prescribed requirements.

## 5. Applications

Applications must be sent through the online form available on the Luiss website at the following link: <https://www.luiss.edu/research/recruiting-calls> without exception, no later than 3pm (CEST, UTC+2) on the **tenth day running from the day after the date of publication** of this call for applications. If the deadline falls on a public holiday, it will be extended to the first working day thereafter.

The following documentation must be attached to the application:

- 1) Curriculum vitae in English;
- 2) Copy of a valid identity document;
- 3) Four-year and/or master's degree certificate or similar academic qualification obtained abroad;
- 4) Not obligatorily, maximum n. 2 most relevant scientific publications and any other documentation and/or certification deemed useful for ascertaining the possession of a professional scientific curriculum suitable for carrying out research activities.

The submission of an application to participate in this comparative selection procedure shall constitute full acceptance of the conditions set out herein.

## 6. Selection Criteria

The selection will be based on qualifications and a possible interview and carried out by a specially appointed Evaluation Committee.

Admission to the possible interview will be established by the Committee after verification of fulfilment of the admission requirements as deduced from the curriculum and documentation submitted by the candidates.

The overall final score -up to a maximum of 40 points- will be given by the sum of:

- the score achieved for qualifications – 30 points
- the score achieved in the possible interview – 10 points

The minimum score to attain eligibility is 24 points.

Commission evaluation is final and unappealable.

## 7. Evaluation Committee

The Evaluation Committee will be appointed after the expiring date of applications submission deadline with a specific Luiss Rector's decree.

The Evaluation Committee shall be composed of:

- the Scientific Coordinator of the project;
- a project team component;
- an external member;
- an internal or external substitute member.

One of the members of the Evaluation Committee will be entrusted with the task of recording secretary.

## 8. Evaluation Outcome

The outcome of the comparative selection procedure and the final ranking are published on the Luiss website at <https://www.luiss.edu/research/recruiting-calls>, as well as the list of candidates called to a possible interview and the timetable and the method/location of the interview. In case of, interviews can be conducted remotely, in person face-to-face at a designated location or electronically through a suitable application.

Finally, the Committee formulates an overall judgement for each candidate and compiles a ranking in descending order based on the sum of the scores obtained. The above ranking will remain valid until the end date of the project for needs directly related to the project and its implementation. In the event of a tie as regards the scores obtained, the youngest candidate shall be afforded precedence. Publication shall be deemed to constitute notification to all intents and purposes.

The winning candidates will be notified in writing of the offer of a contract at the ordinary e-mail address provided when submitting the application. The contract must be signed within 10 days after date of receipt of the offer, failing which the contract will be forfeited.

If the winner is a foreign candidate, he or she will have to meet all applicable labour law requirements for foreign nationals at the time of signing the contract. The contract is individual and indivisible. The contract shall conclude and the associated relationship shall cease on expiry of the term and shall not be tacitly renewable.
