Important Rules

- This study plan is designed for students taking part in the Double Degree Program in Chinese Law and Governance of Sustainable Innovation with the Renmin University of China (RUC) and spending the academic year 2022/2023 at RUC.
- The list of courses to be taken abroad may be subject to changes should the academic offer at RUC be amended.
- Interested students are required to read and understand this study plan and its rules.
 These are to be considered binding to the successful completion of the double degree
 program. Changes to the study plan are usually not possible and any request in this sense
 must be conveyed to the International Development Office, that cannot guarantee its
 feasibility.
- The listed courses must be taken and passed in the academic year indicated in the scheme (not after). Any possible change must be formally authorized by the Academic Commission.
- During the mobility, students will be subject to the rules of RUC.
- At the end of the program, if compliant with both Luiss and RUC academic requirements, students will obtain both a master's degree in Chinese Law for International Students (issued by RUC) and the master's Degree in Law, Digital Innovation and Sustainability (issued by Luiss University).

Thesis

- Students will complete their theses during the 2nd year of the master's degree with one supervisor from Renmin and one supervisor from Luiss.
- Students must respect the thesis procedures and deadlines from both institutions. Each institution will grade the final thesis according to its own standards.
- Students will be assigned a supervisor from Renmin in October of the second year, while students are required to contact and agree on a Luiss supervisor autonomously in due time.
- The supervisors have to approve the proposal and all intermediate and final steps of the thesis, which must meet Luiss and RUC standards.
- Students will defend their thesis of Renmin in May of the second year (by person or remotely upon request) and the thesis of Luiss in Rome in any of the available graduation sessions (starting from July).
- Students are reminded that they are required to comply with the Luiss regular
 procedure regarding the thesis assignment, registration for the degree exam and upload
