THE FULL TEXT OF ARTICLE 6 OF THE CALL FOR MOBILITY GRANTS (OUTGOING SECONDMENTS) is modified as it follows:

#### **Article 6 - Applications**

Applications must be sent through the online form available on the Luiss website at the following link:

<https://luiss.formstack.com/forms/prodigees>, without exception, **no later than 30 (thirty) working days following the publication date of the present Call, at 12 pm (CEST, UTC+2).**

The following documents must be attached to the application:

- curriculum vitae;
- copy of a valid identity document.
- research plan (max 500 words) that illustrates the research ideas that will be carried out during the secondment, including the methodology and the expected results. In addition, it is highly encouraged to indicate how the project links with the work package and the overall theme of the PRODIGEES action.
- declaration of willingness to work full-time (100%) during the secondment for its duration.
