Important Rules

- Interested students are required to read and understand the study plan and its rules. These are to be considered binding to the successful completion of the double degree program. Changes to the study plan are usually not possible and any request in this sense must be conveyed to the International Development Office, that cannot guarantee its feasibility.
- The list of courses to be taken abroad may be subject to changes should the academic offer at Paris Dauphine be amended.
- The listed exams must be taken and passed in the academic year indicated in the scheme (not after). Any possible change must be formally authorized by the Academic Commission.
- During the mobility, students will be subject to the rules of Paris Dauphine.
- At the end of the program, if compliant with both Luiss and Paris Dauphine academic requirements, students will obtain both MSc in Finance (issued by Paris Dauphine) and the Master's Degree in Corporate Finance (issued by Luiss).

Thesis

- Students will complete their thesis during their second year at Luiss with one supervisor and one co-supervisor from Luiss.
- Students must respect the thesis procedure and deadlines from Luiss only.
- Students will defend their theses at Luiss only, in July or in October/November.
- The graduation session in April is not available to students enrolled in the Double Degree. Students can only apply to this graduation session if they withdraw from the Double Degree and would thus obtain only Luiss' degree.
