Important Rules

- This study plan is designed for students taking part in the mentioned LL.M. Educational Program and spending the academic year 2025-2026 at Utrecht University. The list of courses to be taken abroad may be subject to changes should the academic offer at Utrecht be amended.
- Interested students are required to read and understand this study plan and its rules. These are
 to be considered binding to the successful completion of the LL.M. Educational Program.
 Changes to the study plan are usually not possible and any request in this sense must be
 conveyed to the International Development Office and the academic coordinator.
- During the mobility, students will be subject to the rules of the partner university.
- At the end of the program, if compliant with both Luiss and Utrecht University academic requirements, students will obtain both the LL.M. Degree (issued by the Utrecht University) and the Single Cycle Master's Degree in Law (issued by Luiss).

Study Plan

LL.M. at Utrecht is 60 ECTS (45 ECTS taught courses and 15 ECTS for the thesis).

During the V year, students will study at the Utrecht University in one of the following LL.M.:

- LL.M. in Public International Law open to students majoring in Diritto Internazionale
- LL.M. in European Law General Track open to students majoring in European Law, Diritto Amministrativo
- LL.M. in European Law track in European Criminal Justice open to students majoring in Diritto Penale and European Law
- **LL.M. in European Law track in Law and Sustainability** open to students majoring in Diritto Amministrativo, European Law and Law and Innovation
- LL.M. in European Law track in Law and Technology open to students majoring in Law and Innovation, European Law, Diritto ed Economia delle imprese
- LL.M. in Law and Technology in Europe open to students majoring in Law and Innovation
- LL.M. in European Criminal Justice in a Global Context open to students majoring in Diritto Penale
- LL.M. in Law and Economics open to students majoring in Diritto ed Economia delle Imprese
- **LL.M. in Law and Sustainability in Europe** open to students majoring in Diritto Amministrativo, European Law and Law and Innovation

Thesis and Graduation

- Students will complete the thesis for Utrecht following the Partner University deadlines, during the mobility period.
- Students will identify a Luiss supervisor and will need to follow the regular <u>Luiss procedure and</u> <u>deadlines</u> for the graduation at Luiss.
- Once returned to Luiss, they will defend the Master thesis at Luiss in July, in October / November (depending on the availability of transcript of records), or March/April.

Grade Conversion and Conversion Table

The academic activities recognized by the partner university will be transferred according to a Block Transfer Recognition.

During the V year the student will follow courses and take exams at the Partner University, in order to receive the LL.M. Degree. Upon his/her return, all the courses reported on the "Transcript of Records" issued by the foreign university will be recognized on the Luiss student's career through a Block Transfer Recognition, which will automatically recognize all the courses of the Luiss profile chosen (IV year II semester and V year I and II semester).

Grades will be transferred based on the calculation of the weighted average of the LL.M. grades. The weighted average grade of the courses taken abroad is converted following the grade conversion table (see below). Please note that the LL.M. thesis grade is excluded from the calculation. Grades will not be rounded up under any circumstance.
