NOMINATION AND APPLICATION PROCEDURES

Nomination Deadline	8 May for both First (Fall) and/or Second (Spring) semester
Nomination Procedure	All exchange students must be nominated by their home university . The home coordinator must email the nomination sheet to in_erasmusexchange@luiss.it
Application Period	Students are contacted shortly after their nomination and can submit their application until 15 May for both First (Fall) and/or Second (Spring) semesters.
Application Deadline for Second Semester	Luiss does not accept a second round of selected students for the Second (Spring) semester after the summer. Exceptions are very rare and have been pre-agreed with the partners involved.
Application Procedure	<p>Online Application System</p> <p>Application Steps for Incoming Students: After being nominated by their home university, exchange students will receive an email with an access code (token) and instructions to register on our online Web Self-Service platform.</p> <p>Registration Students must register on the Web Self-Service platform by entering the access code, first name, last name, and date of birth. The information entered must match the data provided by the home university.</p> <p>If registration is successful, students will be granted access to the system using their newly assigned username and password. We recommend saving this page or noting down the credentials for future use (a copy will also be sent to the student's e-mail address).</p> <p>Once logged into the system, students can proceed to the next step.</p> <p>Application From the Web Self-Service user page, students should click on Study abroad > Application Form for Incoming students (Erasmus/Exchange) located on the right-hand side of the page.</p> <p>Students will have to upload the following scanned documents:</p> <ul style="list-style-type: none"> • A recent photograph (35x40mm, max 5MB, in JPG, BMP, or PJPEG) * • ID card (for Schengen countries) or passport (for non-EU students) * • Updated transcript of records in English * • Language certificates (if required, check with the home university) <p><i>* Compulsory attachments</i></p>

NB Each semester, a minimum of two exam opportunities will be available for all courses. However, for graduate courses (excluding Law courses, to which the undergraduate course policy applies), students may select only one exam date from the options offered.

The end of the Second Examination Period marks the official conclusion of the academic semester, though most students complete their exams earlier if possible (i.e., within the First Examination Period). Please note that during the First Examination Period, only one exam opportunity will be available per course. Consequently, exam dates and times may overlap, especially for courses from different levels, areas, and years, potentially preventing students from completing all assessments within this period.

REQUIREMENTS FOR EXCHANGE STUDENTS

Academic Requirements	Although a specific minimum GPA is not required, incoming students should be in good academic standing .
Language Requirements	<p>With most of our partners we have agreed that language proficiency will be certified by each home university, confirming that the level is equivalent to at least B2 in English or Italian. As a result, students will not be required to submit an official an official language test result for the exchange program. Please note that knowledge of the Italian language is not required for students studying in English.</p> <p>From partner universities with which we have not agreed on a language certificate waiver, we will require one of the following proofs of language proficiency in English or Italian to study at Luiss.</p>

Attendance of Courses	Full-time attendance of courses is mandatory.
Average Workload	<p>The average workload for students at Luiss is approximately 30 ECTS credits per semester, including Italian language courses. Typically, full-time students enroll in four or five courses per semester, depending on the year of study and academic level.</p>
Minimum Workload Requirements	It is the responsibility of the home institution, but exchange students must take at least one course . Incoming mobility for thesis research is not permitted .
Maximum Workload Limit	Although exchange students are permitted to enroll in up to 40 ECTS credits per semester, they are strongly advised not to exceed 32 credits per semester (excluding the Italian language course).

Courses Exchange Students Can Take

Exchange students will have access **to courses at the Bachelor and/or Master level**, provided they **meet the necessary prerequisites** and there are no major timetable clashes. The more they mix areas and levels, the greater the risk of having timetable conflicts.

Master's courses are at an advanced level, and students **must have the required background and strong language competences**.

Elective Courses

Elective courses in all areas will be offered only if there are enough student registrations. The final list will be available in August.

The Area of Law

The Area of Law offers a five-year single cycle degree program. The courses in the fourth and fifth years are more advanced and equivalent to master's level. In addition, a 3-years bachelor's degree program, **Global Law**, offering 180 ECTS credits, is also available.

Course Descriptions	Course descriptions can be found here . If you do not find some course descriptions, it means they are new subjects and have yet to be published.
Italian Language Course	Luiss offers extensive Italian language courses in both semesters for exchange students who have been admitted to study at Luiss, under an exchange program (Erasmus+ or Bilateral Agreement). The courses are offered at three levels: beginners, intermediate, and advanced, and are free of charge for students . Students who attend the courses and meet the requirements will receive a certificate and earn 3 ECTS credits per semester.
Course Enrolment	Students arriving for the Fall semester will need to make a provisional course registration in June/July , while students arriving for the Spring semester will do so in December . The final course selection will occur at the beginning of each semester . Students will have one week to change courses if necessary. Detailed information will be provided with the acceptance letter. Courses have limited capacity, and the places will be allocated on a first come, first served basis.
Attendance Certificates	Attendance certificates will be provided by Luiss and sent directly to students. The arrival date coincide with the mandatory Orientation Day, and the departure date will be the day of the students' last exam.

EXAMINATION PERIODS AND ASSESSMENT

Luiss Uniqueness – Graduate Degree Courses

Luiss Uniqueness is an educational approach which combines academic rigor and practical relevance to equip students with the critical thinking required to solve daily and future challenges. This unique approach is student-oriented and involves curricular and extracurricular activities that connect students with Luiss university's privileged network of real-world practitioners in business, institutions, and public administration. Via guest lectures, research projects and teamwork, students experience meaningful learning and see first-hand how to play an active and valuable role in society. The Luiss educational journey is one of investigation, innovation, interaction and interdisciplinarity. Students of Luiss graduate degree programs obtain the depth and diligence of scientific research to enable them to think and respond as an innovator and future shaper. Through active teaching methods and an interdisciplinary approach, students graduate with a multi-faceted skills base which boosts their employability in a constantly evolving labour market. This challenging yet exciting learning curve has shaped many graduates, with their educational experience and the spirit of the university influencing how they feel, think, and act.

Examination Periods

Exams are held after the teaching period and can be oral, written, or a combination of both. Depending on the course area and level, some courses will offer two or three examination dates, allowing students to choose the one they prefer.

Graduate level courses will have **two examination dates** available: one in December and January or in May and June, depending on the semester and study period. Students are required to choose **only one exam date**, even if two are available. For these courses, students' performance will be continuously assessed throughout the semester, which will contribute to their final grade. Continuous assessment includes various types of tasks, both individual and group-based, which may be conducted in class or as take-home assignments. The traditional final exam will only form part of the overall grade.

Exact examination dates for each subject will be published approximately a month and a half before the beginning of the examination session.

Students should make their travelling arrangements based on the examination periods.

Final Assessment

Exams can only be taken on the official dates.

Exchange students will take their exams under the same conditions as regular students.

Exchange students are **not** permitted to arrange their exams individually with professors.

Proctored Exams

According to the Italian examination system, **Luiss cannot offer proctored Exams.**

Transcript of Records

Transcripts of records will be sent by email to the Partner Institutions four weeks after the end of each examination period, provided that all exams are completed. Luiss University has embraced an eco-friendly policy, and hardcopies will only be sent to partners who explicitly request them.

Grading System

30 e lode	= excellent
29-30	= very good
27-28	= good
24-26	= satisfactory
18-23	= sufficient
< 18	= fail

Individual courses are graded on a scale of 18 to 30/30. Exceptional students may be awarded 30 cum laude (30 e lode).

The minimum passing grade is 18/30. **Grades below 18 are a considered a fail and will not be recorded.**

Grades below 18 will not appear and cannot appear on the transcript of records, as such grades do not exist in Italy. **Exceptions cannot be made.**

ACCOMMODATION

Housing for Erasmus and Exchange Students

Luiss University, through its Accommodation Office, assists incoming Erasmus and Exchange students in their search for accommodation during their stay.

The following accommodation arrangements are available:

- **Luiss halls of residence** (run directly by the University) and **affiliated halls of residence** (run by a private institution with an agreement with the University). To apply for accommodation at one of the halls of residence, students are required to **apply through an automated online booking system**. The system will process applications in chronological order contingent upon the availability of the desired accommodation.
- **Private rooms and apartments**
Luiss University has signed agreements with some online property rental platforms and local real estate agencies for the selection of private apartments to share with other students.

As spots are limited, accommodation is not guaranteed.

Applying for Luiss and Affiliated Halls of Residence

Incoming students for the first semester or the full academic year must apply online starting from **20 May 2025 at 10 AM** until all accommodation is booked.

To participate in the online booking process, students are required to register **in advance**, beginning on 20 January 2025, via the link that will be published on the Accommodation Office [webpage](#).

Incoming students for the second semester must apply online starting from **24 June 2025 starting at 10 AM** or **21 October 2025 at 10 AM**, depending on their nomination date, until all accommodation is booked.

To participate in the online booking process, students are required to register **in advance**, starting on 3 June 2025, via the link that will be published on the Accommodation Office [webpage](#).

Please note that additional “click days” might be added based on further availability, and that the dates above might be subject to change. It is therefore crucial to check the latest updates and procedures on the dedicated [webpage](#).

VISA AND INSURANCE

Health Insurance

Non-EU students must hold a health insurance policy meeting the following requirements:

- It must cover expenses in the event of emergency or medical treatments, urgent hospitalization, accidents, and injuries.
- It must cover the entire duration of your stay in Italy.
- It must be valid for the territory of all member-states applying to the Schengen Agreement in its entirety.
- It must guarantee the policy-holder's return to his/her own country in case of serious illness.
- It must be translated into English.

EU students must bring their **European Health Insurance Card (EHIC)** which entitles the holder to get necessary treatments at the same cost as an Italian citizen. Students are advised to verify how to get the card and which services are covered with the social security administration of their country before their departure.

Students from non-Schengen countries should apply for a **Study Visa** as soon as they receive the letter of admission from Luiss Guido Carli University.
